ORDINANCE:

Mayor

The No-Parking Ordinance is hereby Amend to allow parking, for Official Police Department business only, of vehicles in the Pertinent Areas that display: (I) Police Department colors and insignia, or (ii) M" license plates or (iii) temporary placards issued by the Police Department. The Commissioner of Transportation is authorized and directed to implement signage at the Pertinent Areas to give effect to this ordinance. Pursuant to previously passed ordinance (the "No-Parking Ordinance"), no-parking zones are currently in place on two portions of south side of West Van Buren Street: (i) from South Loomis Street to a point 800 feet west thereof, and(ii) from 100 feet east of South Loomis Street to a point 475 feet east thereof (the "Pertinent Areas") [O2017-173]
