3. County Administrative Officer's comments on the FY 2016-17 Recommended Budget.

County Administrative Officer Dr. Lew Bauman presented the Fiscal Year (FY) 2016-17 Recommended Budget.

Report of the Budget Committee and Comments by Board Members.

Supervisor Armenta thanked the CAO Budget staff, the public and Supervisor Parker for their support and service to the Budget Committee. He noted that all County Departments sacrifice and made decisions in the face of challenges this year, as in past years. He advised that we all need to be more creative and flexible in making adjustments throughout the year in order to do more with less. He reminded everyone to be more responsive to Monterey County residents. He thanked Supervisor Parker, County residents and staff for their efforts.

Supervisor Potter thanked Supervisor Salinas for a well-done, hard worked year. He noted that the County has been tasked with more capital improvement projects this year and that it is imperative that the Board be kept apprised of the projects in order to assure projects come in on time and on budget. He recommended that the ERP Project be treated as a Capital Improvement project, financed accordingly, and charges should be assessed through the COWCAP system. He commented that the County should know the actual costs of the system and, although this isn't before the Board today, the Board should decide today whether this warrants designation as a capital improvement project. He specified Fund 403 on page 690 of the Budget book as a possible funding resource.

Supervisor Salinas commented that the Board deals with increasing needs and challenges in receiving revenue from Sacramento & Washington and this requires the Board to priortize diverse needs and resources. The Board has to pay attention to the needs of local constituencies. Everyone will do all possible to balance the needs and resources. He pointed out a misspelling on page 562, second column of the Budget book.

Supervisor Phillips advised that budgets are always a tough and this year is a especially trying. There are necessary capital and long needed improvements to the jail, juvenile hall, and the East/West wing. He agreed that while the ERP system project is necessary, exploring financing the project as a capital improvement project makes fiscal sense, because costs have increased by \$11 million dollars. This has significant impacts to the departments, small and large.

Supervisor Parker expressed her appreciation to County staff for their work on the budget. As a member of the Budget Committee, she noted they are looking at various long term sustainability issues that are being studied with departments. Recommendations will be coming forward throughout the month, including a recommendation from Economic Development to look at the formula for Transient Occupancy Tax (TOT) allocations and its sustainability over time. The committee has requested options be provided for review before bringing this to the full Board. Other issues include, the Public Defender's Office study, which indicates a need for the allocation of more resources to that department. The Budget Committee has requested that the Public Defender provide an implementation plan and timeline for further evaluation.
